When multiple memberships are listed together in this agreement, each are charged the \$800 fee. All amounts due agent under this agreement are due at the closing of the sale for that membership.

For any sale that occurs within 60 days of the cancellation date, the seller agrees to pay agent the sum of \$400.00 in addition to the normal transfer fee</li> <li>b.
