Safari mailing costs are increasing. To save money, we are encouraging all members who have email to agree to get the documents via their email. Requests have been sent to those members.

As you may have seen in the minutes of the May meeting, Safari lost many members since last September. We are so sorry for their loss. These passings have brought challenges to requests by the survivors. Some of our members have not added Joint Tenant with Right of Survivorship to their memberships. This is simple procedure that requires a signature and then the membership has this added. With this, if a member dies, the remaining member can easily have the other name removed from the membership. Without this, we require more legal documentation. Please consider doing this and contact the office to take care of it.

We understand our twice a year billing can sometimes be a financial burden. To help avoid the surprise, consider making monthly pre-payments. Your pre-payments will be credited to your account, safely deposited in the bank, and will not be spent until billing time. The nice thing about doing this, is come billing time, you'll have less to pay and maybe even have a credit toward your next bill. Please consider taking advantage of this. One member, who does this,

Pacific County has been moved to Phase 3 but gathering sizes are restricted to 50 people. With that in mind, the Board will once again do a virtual video meeting for the July 18, 2020 membership meeting. In addition, the virtual video meeting will be shown in the Lodge at 1:00. As was mentioned in the previous meeting, Tom and Orville inspected lots after the heavy winter rains to check sewer hook ups. Several were found to be too close to the ground and were admitting rainwater into the sewer system. Some were found to not be air/watertight. Also found were water hook ups that were leaking and wastefully adding to our water bill. In addition, several meter pedestals were rusting and in need of work. All these items are the responsibility of the members. Notices have been sent out and will be checked for completion.

At the July meeting, members running for positions will be giving their speeches. The Board positions to be voted on in September include: President, Vice President, Finance Director and Assistant Secretary-Treasurer. The President position was appointed by the Board with Orville Aas resignation. This position must be voted on in September. The Vice President position, vacated by the appointment of Dave Krajcar to the President, has been filled by Board appointment and must be voted on by the membership.
